## **EDUCATIONAL LOAN SCHEME RULES**

1. The assistance under EDUCATIONAL LOAN SCHEME will be given to Kutchi Visha Oswal students of Gadhsisa.
2. The loan will be given for higher studies in India or abroad or as decided by **Shri Kutch Gadhsisa Jain Mitra Mandal** from time to time.
3. The application form has to be completed in all respect. Incomplete application, furnishing false information and hiding of any information will be liable for rejection of application **Shri Kutch Gadhsisa Jain Mitra Mandal** reserve the right to disburse the loan amount in full, part or reject the application without giving any reasons.
4. The student and his/her earning parents/guardian have to sign the application form and the loan agreement at the time of receiving the loan and will be responsible for timely repayment of the loan.
5. If the loan is not used for the specified purpose **Shri Kutch Gadhsisa Jain Mitra Mandal** will have rights to call back the loan amount along with the interest thereof at the rate of 18% per annum.
6. The applicant has to submit the application along with two KVO guarantors in the enclosed form. One guarantor should be from his village in kutch and other from a business man/professional field of specialisation.
7. Application has to enclose following document along with his application : Copy of Ration Card, Copy of Last Exam Pass Certificate / Mark Sheet, One passport Size photograph, Copy of College/Coaching Classes Fee receipt, admission Letter/1-20 letter copy of Passport and Visa (last three items for student going abroad).
8. The loan repayment will start after three months of the completion of course for which loan is availed or the generation of income by student during his studies whichever is earlier: (alternatively, the student/guardian can start repayment immediately after receipt of loan so as to reduce their cumulative burden.) The loan amount has to be repaid between the 1st and 5th of every month as decided in monthly or quarterly installments or a penalty will be charged as decided by **Shri Kutch Gadhsisa Jain Mitra Mandal** from time to time.
9. Any change in material information supplied in this application, change in address, telephone numbers of applicant or guarantors has to be intimated to **Shri Kutch Gadhsisa Jain Mitra Mandal** immediately.
10. The student communicate the progress / result of his educational exams every year. Failure to furnish results will result in cancellation of loan and action will be initiated to call for the loan.
11. The student going abroad with assistantship should start repaying loan within six months of reaching abroad.
12. The student proceeding abroad without getting assistantship should intimate the **Shri Kutch Gadhsisa Jain Mitra Mandal** as soon as the assistantship is confirmed. In such cases loan repayment will start within six months of receipt of assistantship.
13. In case the student, taking the loan, is unable to complete his education or drops out of college then he should inform **Shri Kutch Gadhsisa Jain Mitra Mandal**. He should repay entire loan within 30 days of his dropping out. The conditions enumerated at item no. 5 Rules regarding interest rate and recovery form guarantor will apply in this case.
